Financial Consent – Billing Policy for Private Patients

Dear Patient,

It is a requirement under the Medicare Australia guidelines to provide informed financial consent to all patients. Private health insurers also require this process to be undertaken formally and the information below is provided so you can make informed decisions about the care you require and the associated expenses.

PLEASE NOTE: : For review appointments, you will need a new referral letter from your GP if your referral has expired. A referral from your GP is only valid for 12 months from when your GP has dated the letter. For you to claim your rebate through Medicare, you must have a current referral letter.

Item 110 will be charged again, as your conditions may change in view of the chronicity of the neurological disorders; or item 132 if the consult is extensive. If affordability is an issue and you still want a neurological follow up, please kindly ask your GP to refer you on to ICAN as Dr Tho is a VMO neurologist (www.ican.edu.au)
